Community Development: No report available

**Governmental:** Greg Mellowe provided an update on several external issues:

- 1) Board is working on job descriptions for the various committees.
- 2) Historical Marker request was submitted, and we are waiting for the state's approval.
- 3) FDOT thanks to everyone that submitted comments for lighting -50 comments were submitted, and we hope to hear an update by next month.
- 4) Coast to Coast gaps in Lockhart we want to get signs for the interim solution of using Rose Avenue. We need to get the section near the railroad tracks cleared/fixed before the May 12<sup>th</sup> Coast to Coast Trail Tour.
- 5) Support letter obtaining Federal Grant revitalizing Edgewater Drive. Alex from Commissioner Moore's office added update that we are in the study phase then it will move to the design phase. This will bring a lot of infrastructure and bring businesses in.

6) The proposed rezoning of the Robbins Lumber property to industrial has been continuously postponed, likely pending resolution of the question of whether pressure treatment historically performed on the property can continue regardless.

**Spirit:** Toni Cheatle continues encouraging subdivisions to decorate for holidays. Additional comments from the floor stated how successful this has been on Magnolia Homes Road.

**Events:** Lindsey Smestead is overwhelmed and thanked everyone for the support she has received for the Easter Egg Hunt, Alex from Commissioner Moore's office handed out flyers that members can pass along to friends, family and neighbors. So far 93 children have registered, 18 vendors, bounce house, balloons, face painting, food trucks, plus 52 volunteers. Lockhart 150 celebration will take place late September or early October.

## **Guest Speakers:**

Brett Blackadar, Deputy Director of Public Works Orange County Government – started this position 4 months ago and has a passion for traffic safety. He spoke about several topics – Vision 0 – goal to get to 0 fatalities and serious injuries; Metro Plan Orlando – prioritize Federal funding. Curbing being added to Beggs Road just north of Hiawassee; grant has been submitted for Edgewater to look at safety for bicycles and pedestrians, they are redoing the study to reimagine the corridor; Study being done on Clarcona Ocoee Road focusing on speeding, access management and intersection improvements; resurfacing 4441 construction to start in 2023; and Coast to Coast Trail.
